CANCELLATION POLICY:

If written notice is received prior to 60 days from the show, 75% of monies will be returned. All cancellations made within 59 days of the show are non-refundable.

Insurance Requirements:

The Ontario Approved Professionals requires that each exhibitor provide a "Certificate of Insurance" for Commercial General Liability (CGL) with a minimum of \$2 million coverage for the two days of the Trade Show naming the Ontario Approved Professionals as additional insureds. Your insurance provider can assist you with this document.

ADDITIONAL ITEMS:

- 1) Hydro, Wi-Fi & Booth Curtains are included in the booth booking fee.
- 2) Tables and Chairs <u>are not</u> included in the booth booking fee, See Vendor Form.
- 3) Table Linens, Extension Cords and Carpeting are not supplied by Organizers.
- 4) Event Organizers will arrange radio, print and social media advertising.
- 5) Exhibitors are encouraged to do their own advertising in support of the show's success.

GENERAL INFORMATION:

1) The dates and times of the running of the Home & Trade Show are as follows:

- 2) The lessee will be able to set up their booth as follows: Setup Day 01 – Wednesday, March 20, 2024 || 10:00am ~ 4:00pm Setup Day 02 – Friday, March 22, 2024 || 10:00am ~ 2:00pm
- Arena access will be available through a 12ft wide by 13ft high Overhead Door. Vehicles will be permitted on the exhibition floor surface during Setup Day 01 only.
- 4) Tear down times, with no exceptions, are as follows: Tear Down Day – Saturday, March 23, 2023 || 2:00pm-7:00 p.m.*One Day Only
- 5) Booths are not permitted to be taken down before the end of the show.
- 6) The booths will be leased on a First Paid, First Reserved basis.
- 7) The event coordinators reserve the right to assign booth spaces as required.

LESSEE'S RESPONSIBILITIES

- 1) The lessee is responsible for providing all required items, carpets or matting, fixtures, extension cords and other items for their booth and its operations.
- 2) The lessee will not be permitted to glue or nail any material to fixed portions of the arena: walls, ceilings, floor, and curtains. Hanging or fastening display material to fixed items within the arena must have prior written approval from the event coordinator and/or arena supervisor.
- 3) The lessee will also be responsible for the daily clean-up of the immediate area within their booth, and to ensure that measures have been taken to protect the facility from spillage, oil, gasoline, grease and/or any other liquid products.
- 4) It is the responsibility of the lessee to ensure that all materials and furnishings required in their booth set up are taken down and removed from the building and their booth area is left in the manner in which it was received.


